Every five (5) years we must have a review of our By-Laws and Standing Rules. Many thanks to the Review Committee for their review and updates. We will vote on the changes at the Wednesday Business Brunch. Here are the revisions for you to look over before the vote. Changes are in red, with the explanation shown at the end. A mound of gratitude goes out to our Standing Rules and By-Law Review Committee: Marilyn Brath, Judy Waring, Fran Laue, and Abby Elliott. This is a tough job and we appreciate you volunteering to take on the task. Thank You!

By-Laws of the Wing of the Aerospace Medical Association – 2019

ARTICLE I: NAME

The name of the organization shall be the Wing of the Aerospace Medical Association (AsMA). It shall be incorporated under the laws of the District of Columbia.

ARTICLE II: OBJECT

The Wing is a non-profit social and educational organization whose objects are:

- a. To support the specialty of aviation, aerospace, and environmental medicine by facilitating cooperation among its practitioners and by increasing public understanding and appreciation of its importance.
- b. To promote and increase sociability among the members of AsMA and their families.

ARTICLE III: MEMBERSHIP

Section 1. The Wing shall consist of the following memberships: Active members and honorary members.

Section 2. Active members shall be spouses, domestic partners, adult family members, or other individuals sponsored by members of AsMA in good standing. Membership eligibility will continue for these categories upon the death of the sponsoring AsMA member.

ARTICLE IV: OFFICERS

Section 1. Officers of the Wing shall be the following active members: President, First Vice-President, Second Vice-President, Secretary and Treasurer. The term of office shall be for a period of one year, commencing with the first Executive Board meeting following the election.

Section 2. The First Vice-President shall be the President-Elect and will be installed as President at the close of the annual meeting; the Second Vice-President shall then automatically become the First Vice-President.

Section 3. The Secretary, Treasurer, and Second Vice-President shall be elected at the annual business meeting of the Wing by a majority of the active members present. The Nominating Committee shall place in nomination a candidate for each of the offices, and its report shall be appropriately published and posted in a prominent place on the first day of the annual meeting, but not less than 24 hours prior to the beginning of the annual business meeting of the Wing. Additional nominations sponsored by **three (3) current accredited members** of the Wing may be offered from the floor at the annual business meeting, at the time the Nominating Committee makes its report, providing the members sponsoring the additional nominees present to the Wing Secretary written notice at least three (3) hours prior to the Wing's annual business meeting. The written notice shall include the name of the nominee, the office for which nominated, and the signatures of the required number of qualified sponsors. If there is more than one nominee for an office, a secret ballot shall be cast for that office.

Section 4. The President shall be the head of the Wing during the tenure of office and shall preside at all meetings of the Wing and of the Executive Board. The President shall serve as an ex-officio member of all standing committees and shall perform such other duties as are customarily accomplished by a holder of this office. The President shall appoint a Parliamentarian and up to five (5) active members to serve as Board Members-at-Large.

Section 5. In the absence of the President, the First Vice-President shall preside at meetings of the Wing and of the Executive Board. If the President is unable or unwilling to complete the term in office, the First Vice-President automatically succeeds the President.

Section 6. The Secretary shall be responsible for the minutes of meetings and for all official correspondence. The Secretary shall be the custodian of all documents and other reports, which comprise the permanent records of the Wing.

Section 7. The Treasurer shall collect all dues of the Wing and make such expenditures there from as may be authorized by the Executive Board. The Treasurer shall render an account of the financial status of the Wing, upon request of the President, at each meeting of the Executive Board. The Treasurer shall also present a financial statement at **the annual Business Meeting** of the Wing, which **could be subject to internal audit**. The Treasurer shall maintain a current roster of members.

Section 8. The President may, if deemed desirable, appoint one or more active members as assistant to the Secretary, and/or the Treasurer in the performance of the duties of their offices.

ARTICLE V. BOARD

Section 1. There shall be an Executive Board consisting of the President, Honorary President, First Vice-President, Second Vice-President, Secretary, Treasurer, Parliamentarian, two (2) immediate Past Presidents, up to five (5) active members appointed to serve as Board Members-at-Large for a period of one (1) year, and **Chairs** of Standing Committees.

Section 2. The President of the Wing shall be the **Chair** of the Executive Board.

Section 3. The Honorary President of the Wing shall be, with that person's consent, the spouse **or adult representative** of the incumbent President of AsMA and shall be a non-voting member of the Executive Board.

Section 4. The Executive Board is the legal representative of the Wing, and, as such shall have, hold, and administer all the property, funds, and affairs of the Wing.

Section 5. There shall be at least two (2) meetings of the Executive Board annually. Five (5) voting members of the Executive Board shall constitute a quorum; and there shall also be a planning session whose participants shall consist of at least five (5) members of the officers of the Executive Board.

Section 6. The President, with the Board's approval, may select an active member to fill any vacancy that occurs in an elective office for the remainder of the unexpired term.

ARTICLE VI: COMMITTEES

Section 1. The Wing shall have the following Standing Committees, which are appointed by the President to function during the term of office: Membership, Publicity, Arrangements, Resolutions, Registration, and Advance Registration.

Section 2. The Nominating Committee shall be the two (2) most recent Past Presidents of the Wing and the five (5) Board Members-at-Large. The most recent Past President shall be the chair of the committee.

Section 3. Other standing committees, or special committees, may be appointed at the discretion of the President.

ARTICLE VII: MEETINGS

The Wing shall meet at least once a year at the time and place of the annual meeting of AsMA. Ten (10) percent of the membership shall constitute a quorum.

ARTICLE VIII: FINANCES

Section 1. For each fiscal year, active members shall pay annual dues as established by the Executive Board. The fiscal year shall begin with the installation of the new Executive Board at the convention and shall end at the termination of their year in office. These dues are payable **not later than the close of registration at the annual meeting of the Wing**.

Section 2. Any eligible member dropped for non-payment of dues shall be reinstated by payment of dues for the current year.

ARTICLE IX: AMENDMENTS

Section 1. Any article of these Bylaws may be amended or repealed at the annual meeting of the Wing by a two-thirds affirmative vote of the members present.

Section 2. Any proposal to amend these Bylaws shall be submitted to the **Chair** of the Resolutions Committee by three (3) or more members of the Wing at least 45 days prior to the date of the annual meeting. The proposed amendment shall not be presented to members of the Wing at the annual meeting unless it is approved by a majority vote of the Executive Board.

ARTICLE X: RULES OF ORDER

The latest edition of Robert's "Rules of Order" shall be the Wing's authority on all questions of procedure and parliamentary law not covered by these Bylaws.

ARTICLE XI: DISSOLUTION

In the event this organization shall formally disband or dissolve, any remaining assets, after all expenses have been paid, shall be donated to the Aerospace Medical Association.

Article V, Board, Section 5 amended May 2001—2 Board meetings & one planning session ("conference call") annually with 3rd board meeting eliminated.

Reviewed, no changes, 2004.

Bylaws amended 2006 eliminating future selection of Honorary Members and the requirement that "a representative of any one constituent group may not be elected to the office of Second Vice-President more than once in each two (2) years."

Article VI, Section 2 amended May 2007 Nominating Committee Chair to be the most recent Past President not the 2nd Past President.

Article VIII, Section 1 amended May 2008 so dues amount change doesn't require vote of members at annual meeting.

Article III, Section 3 amended May 2009 Associate Membership category changed.

Article VI Section 2 amended May 2007. Nominating chair to be the most recent Past President, not the Second Past. Published in the 2012 directory.

Article III, Section 1, amended May 2014. Eliminated "Associate Members"

Article III, Section 2, amended May 2014. Section now reads "Active members shall be spouses, domestic partners, adult family members, or other individuals sponsored by members of AsMA in good standing. Membership eligibility will continue for these categories upon the death of the sponsoring AsMA member."

Article III, Section 3, amended May 2014. Eliminated "Associate Member" and section regarding them.

Article IV, Section 3, amended May 2018. Eliminated "and the Board Members-at-Large" and inserted "and" between Treasurer and Second Vice-President.

Article V, Section 4, amended May 2018. Amended the final sentence to read: The President shall appoint a Parliamentarian and up to five (5) active members to serve as Board Members-at-Large.

Article V, Section 1, amended May 2018. Changed "elected" to "appointed" regarding the Members-at-Large.

Changes to be voted on by membership at Annual Business Brunch on May 8, 2019.

Article IV, Section 3, amended May 2019. Eliminated "two (2) percent" and inserted "three (3)"; changed the word "membership" to "members"

Article IV, Section 7, amended May 2019. Eliminated "each" and inserted "the annual Business Meeting"; Eliminated "shall be audited either internally or externally" and inserted "could be subject to"

Article V, Section 1, amended May 2019. Changed the word "Chairmen" to the word "Chairs"

Article V, Section 3, amended May 2019, after the word "spouse" inserted the words "or adult representative"

Article VIII, Section 1, amended May 2019, Eliminated "on receipt of a bill rendered by the Treasurer" and inserted "no later than the close of registration at the annual meeting of The Wing."

Article IX, Section 2, amended May 2019, Changed the word "Chairman" to the word "Chair"

THE WING OF AsMA

STANDING RULES

1. A Bylaws Committee shall be appointed every 5th year by the President to review and amend the Wing's Bylaws and Standing Rules. [Note: Standing rules reviewed by committee October 2018 with suggested changes noted here for review and approval.]
2. Changes to Standing Rules will be voted on by the Board and Bylaws changes need general membership votes.
3. The Treasurer is authorized to pay any and all expenses within the budget as approved by the Board. All other expenses will be reviewed by the President and Treasurer on a case-by-case basis with any major expense exceeding \$500 requiring Executive Board approval.
4. Checks may be written in the name of the Wing by the Treasurer and another designated signer on the account.
5. At Board meetings, all elected officers, board members-at-large, and committee chairs are voting members of the Executive Board with the exception of the Honorary President, who is a non-voting member. Under Article V, Section 1 of the Bylaws, "Finances," you will find that the fiscal year begins when the new board takes over, thereby necessitating only the new board members voting on budget or other items for their coming year.
6. At the expiration of their term, each officer and committee chair shall review the list of duties for her position and recommend to the President any change or addition needed.
7. Committee reports shall be e-mailed to the new President and Secretary, and the Secretary shall keep one hard copy on file.
8. Official Wing Representatives at any outside meeting or function must be appointed by the President.
9. Honorary Members shall receive all communications from the Wing.
(Note: Although we no longer appoint Honorary Members, we still have one or two who attend the luncheon or reception, and in the spirit of inclusion, we should continue to send them both the newsletter and a directory.)
10. Payment for a lost Past President's pin or Honorary Member's charm must be received before a replacement is issued.
11. The Wing's spring and fall newsletters shall be sent by email to all members.
12. For eligibility to attend the Welcoming Reception, refer to the current registration policy. Cancellations by conference registrants may result in a refund of registration fees paid with advanced notice of cancellation (i.e., before the onsite registration). Tour and business meeting tickets are not refundable, but the tickets can be resold. Registrants may give their tickets to other eligible attendees.
13. Flowers or a memorial shall be sent in the instance of the death of a Past President or spouse of a Past President. In all other instances, the Treasurer shall send flowers or a memorial at her/his discretion or as a result of consultation with the President or First Vice-President. Sympathy cards or notes of condolence shall be sent to other members or their spouses by the Secretary as such information arises.
14. The Wing will pay for one trip for the President and for the Arrangements Chair to visit the convention site prior to the convention. This visit will coincide with the visit by the AsMA convention representatives. Reasonable expenses for airfare and hotel charges (up to two nights) can be reimbursed, as allowed by the budget.

15. The President, in consultation with the Treasurer, shall allow the Arrangements Chair to increase **her/his** budget as deemed necessary.
16. The Wing will pay the President's travel expenses to the annual meeting, not to exceed the amount budgeted by the Board.
17. **Registration for the Wing conference is limited to Wing members and those sponsored by an active member of AsMA. Wing registrants receive an invitation to the Welcoming Reception and a nametag that provides them access to AsMA scientific sessions.**
